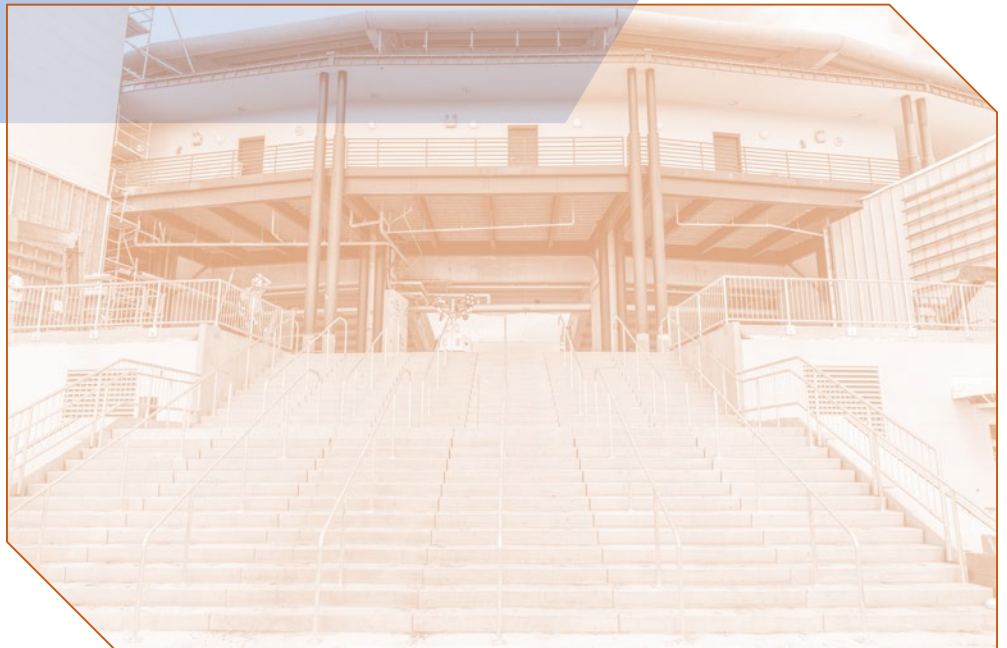

Document Uploads

Purpose:

To submit a variety of permit related documents, such as, as-built surveys, formboards, termite certificates, notice of commencements, etc. Provides a direct way to add documents directly to the permit along with notification once processed and approved by staff.

In addition, owners acting as their own contractor when building or improving must prove the occupancy is for their use only and not offered for sale or lease. 

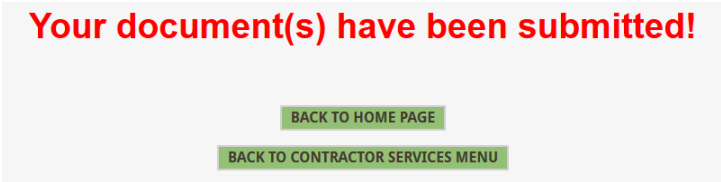
